Participants assume all liability for any and all losses or damages, whether personal or property, which may arise from this trip.

Any medical expenses incurred by or on behalf of individual participants must be reimbursed to American Music Abroad and its staff; such special expenses shall include but not be limited to medical or psychological care, drugs or other treatments, transportation including airfare to or from any point for any reason including ill health and communication costs.

American Music Abroad does not act as warrantor or guarantor for the various companies, institutions and associations whose services; accommodations and equipment are made available in connection with its tours. American Music Abroad expressly assumes no responsibility or liability arising from the provision or use of any such equipment and/or services, including but not limited to transportation, room, food and performance sites.

All rates are based on tariffs and costs in effect November 2017 and are subject to change and/or confirmation when final payment is made. In the event that it becomes necessary or advisable, for any reason whatsoever, to alter the itinerary or arrangements, such alterations may be made. Additional expenses, if any, shall be borne by participants, conversely, refunds will be made if any savings is effected.

Any and all rights, demands, actions, causes of action and claims for injury, damage and/or loss arising during the period of tour membership or under this agreement that a participant may have against American Music Abroad, its organizers, owners, employees and volunteers, both personally and in their official or professional capacities shall be waived and released by the tour participant; this waiver and release shall include but not be limited to any and all claims which may result from American Music Abroad's exercise of discretion, service or transportation providers and equipment, and the acts, defaults or defects thereof, as well as any and all damages arising from natural or political events.
